NOTES AND FOOTNOTES FOR U.S. COAL EXPORT/IMPORT TABLES

NOTES:

1. Coal export values are F.A.S. (free alongside ship) values at the U.S. port of export, based on the transaction price, including inland freight, insurance, and other charges incurred in placing the merchandise alongside the carrier at the U.S. port of exportation.
2. Tables exclude shipments to U.S. military forces.
3. As considerable price variations exist between different grades and sizes of coal, the average value per ton only approximates actual price movements.
4. Due to rounding, zeros may indicate tonnage less than 500 short tons.
5. Import codes changed in 1989. Some imports reported as briquettes were actually coke imports.
6. Import codes changed again in 1998. Some imports previously reported as briquettes (coke and semicoke of coal not commercially suitable for fuel) are now being classified as coke imports. Beginning in January 1999 based on new industry information, NMA removed "coke and semicoke of coal not commercially suitable for fuel" from the ICR briquettes import table and included it in the coke Imports table.
7. Exports and imports of "Other Coal", code 2701190000, increasingly containing some subbituminous coal, is now being reported in the ICR steam coal export and bituminous coal import tables beginning with August 2003 data.
